Meter Installation / Membership Fee

Installation includes the meter assembly, backflow preventor, and customer shut-off valve placed on the County Right Of Way adjacent to the member's property or closest point.

Base Rate / Availability Charge

Paid regardless of water usage. ERU = \$26.00 An ERU is equal to 2500 square feet and 4000 gallons of water. Larger homes will be assessed a higher base / availability rate based upon the square footage of the home with an additional ERU added for every additional 2500 square foot of living space or portion thereof. For example: 1 ERU = \$26.00 and 4000 gallons. 2 ERUs = \$52.00 and 8000 gallons.

Residential Overage Fees

Overage fees are billed in increments of 100 gallons. The base rate includes the first 4000 gallons. Each additional ERU includes an additional 4000 gallons.

8100 – 12000 Gallons	\$ 0.375
